

## APPROVAL TO ESTABLISH A STATE PROJECT FACILITATION FUND WITH 3% CAPITAL ALLOCATION

19. By leave of the Chairman, the Commissioner for Finance presented Memo CRSEXCO 2025/89 to Council for consideration and necessary approval. The memo proposed the establishment of a State Project facilitation Fund. He drew Council's attention to the fact that in ensuring the operational readiness of the aforementioned Fund, an initial capital allocation equivalent to 3% of the total estimated Public- Private Partnership (PPP) investment portfolio for the 2026 fiscal year is recommended.

20. Council was further informed that SABER has a total finance credit package of **₦26,000,000,000.00 (Twenty-Six Billion Naira)** only to help fund Public – Private Partnership Projects. The eligibility criteria for accessing these funds is based on our ability to present evidence of Cross River State Facilitation Fund establishment through legal or administrative means and the 3% funding which in this case sums up to

**₦ 780,000,000.00(Seven Hundred and Eighty Million Naira only).**

The total breakdown of the utilization of the funds through the Private – Public Partnership is as provided in the table below:

The Commissioner for Finance therefore presented the draft Cross River State Public Private Partnership Framework, Project facilitation Fund Business Plan, Rules, Governance and operational Manual to Council for its consideration and necessary approval.

21. During deliberation, Members were enthusiastic about the benefits the portfolio is estimated to bring to the State and consequently endorsed the


